PDI 2015 Policies

Cancellation Policy: Cancellations must be received in writing by April 30 to obtain a partial refund. All refunds will be subject to an administrative charge of \$50.00. Cancellations of pre PDI sessions will be subject to a \$10.00 administrative fee. Persons who register and fail to attend will not receive a refund.

Registration Type Change Policy: Changes to registration type, such as PDI attendee to virtual registration will be refunded or charged the price difference. There is no administrative fee for this type of change.

Substitution Policy: After May 1, persons substituting for other individuals at onsite PDI will be required to complete a transfer form in New Orleans. Payment of registered attendee must transfer to the substitute to be considered a substitute and include both PDI and Virtual PDI registrations. New attendee must qualify for the paid registration rate.

Change of Payment: Any change to payment method will be subject to a \$50.00 charge.
